The solution integrates specific content management capabilities with advanced rule based technology. Without any kind of programming users are able to do modeling within the tool. The tool can generate advanced checklists that fit the specific situation exactly. Product is ready for use, and already up and running for one of the largest Ministries of the Netherlands.

The EasyRules Suite is the common off the shelf product that is designed and developed to support the law & regulation inspection, preserving and compliance processes. The Product combines the advantages of Knowledge Management, Content Management and Business Rules Technology within one integrated environment. The EasyRules suite can be used to store & retrieve laws and regulations and it also contains a rule base based on which checklists and e-forms can be generated automatically. The suite is specially designed to support the law inspection and preserving processes. It can also be used for much simpler tasks like interactive license and permit requirement checking. This product is available in 3 different platforms: Desktop Application, Web based application and Mobile Application (WAP Site). The website is developed on more than one language platform (Dual language as - Dutch and English). The same databases are using across the three different platforms. The website is providing full text search functionality to the users along with the advance document navigation facility. Site users should require login first to access the website and users only would able to get information as per their provided search criteria.

- 5. Use new Oracle Database 10g features like Materialized Views, Hierarchy Queries and their ability to improve performance and to reduce time to manage database.

- 1. Phase I: Analysis the System Flow, database design and dependable entities. Review risk points of database and application.
- 2. Phase II: Create new applications Desktop, WAP and Web Service.
- 3. Phase III: Testing all features and making deployment plan.
- **4. Phase IV:** Setup of testing environment (same as the production environment) and creation of same workload as production environment.
